#### 1 Competition Organiser

#### 2 Date of Competition:

The Competition will be held on Monday the 8th of February 2010

#### 3 Language for Presentations

All presentations must be in English, the official language of the Congress.

#### 4 Entry to Competition

- Nominees from any affiliated society/association of WFO are eligible to enter the Competition. Each affiliated society/association may nominate one competitor.
- The selection of the individual competitor for a particular society is the responsibility of the relevant national orthodontic society.

#### 5 Final date for entries

The final date for entry to the competition is 31 October 2009. All competitors' names and titles and outlines of presentations must be submitted to SIOCC by this date. Finalists will be advised by 30 November 2009.

#### 6 Presentation Format

All presentations are limited to 10 minutes duration and must be the presenter's own work.

Visual aids should be computer generated and in a commonly used format such as Microsoft Powerpoint.

A CD or usb stick with a copy of the presentation should be forwarded to the Congress organizer, ICMS, by 10th January 2010. ICMS will test the presentation for compatibility with the Congress audiovisual system.

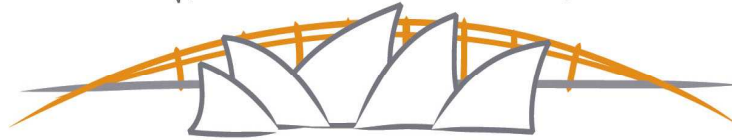

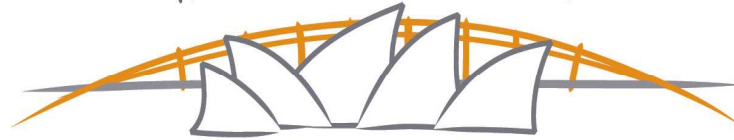

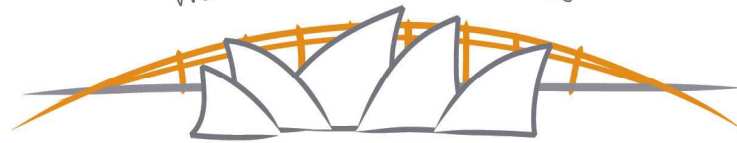
